Title: Creative Schools Teaching Artist

Reports to: Creative Schools Program Manager

Hours: 20-26 hours/week, August to mid-June from 2015 to 2018 **Compensation:** \$21.26/hour for 46 weeks/year plus benefits

Job Description: The Creative Schools Teaching Artist will collaborate with 5th and 6th grade teachers in Highline Public Schools to deliver project-based arts integrated units. In the fall of 2015 the Creative Schools Initiative is entering into a three-year project in the Highline School District funded by the U.S. Department of Education. Arts Corps is hiring four teaching artists (two visual artists and two theatre artists) who will teach units that integrate visual art/theatre with language arts in order to enhance student learning, classroom engagement and feelings of belonging. Each teaching artist will split their time between two elementary schools where they will contribute to an arts rich environment by coteaching in the classroom, supporting students' online portfolios and guiding exhibits/performances with students. Creative Schools Teaching Artists will also be responsible for the support of professional development for classroom teachers, program evaluation and some administration as it pertains to their school sites.

Primary responsibilities:

- Provide integrated arts instruction for two Highline Creative Schools sites
- Collaborate closely with teachers to understand curriculum, prepare lessons, develop coteaching strategies and co-teach integrated units
- Support the planning and implementation of professional development for classroom teachers, including development of strategies for supporting academic mindsets, race and social justice in schools, and best practices in arts integration
- Support teachers and students to use online portfolios to document their learning and growth
- Celebrate student work with exhibits and/or performances
- Support program evaluation and research
- Support documentation collection
- Participation in planning and steering meetings at school sites
- Management of communication and administration as it pertains to the partner schools and the Creative Schools Initiative

Qualifications:

- Proficiency and depth of knowledge in one or more art form
- Experience teaching arts education with upper elementary age students
- Experience teaching integrated arts curriculum in schools
- Knowledge of the common core standards, and national and state arts standards
- Capacity for working at least 20 hours per week, including some evenings and weekends during the school year
- Availability during the month of August. During the summer of 2015 this will include at least five days of training in early August and a three day teacher professional development from August 12-14, 2015
